Financial Internal Controls Monitoring and Support

On December 20, 2013, as a result of a General Service Administration (GSA) competition, a labor hour GSA delivery order (NRC-HQ-7N-14-T-0001) was awarded under contract GS23F8152H to Ernst and Young LLP of Washington, DC. The contractor shall provide ongoing internal control documentation and monitoring support in accordance with Office of Management and Budget Circular A-123, particularly Appendix A, "Internal Control Over Financial Reporting." The period of performance is December 20, 2013, through December 19, 2014, with four 1-year option periods. The total value of the contract is \$1,049,538.03, including all options.

Security Requirements for Facilities Storing Spent Nuclear Fuel: Draft Regulatory Basis; Availability of Response to Public Comments; 10 CFR Parts 72 and 73 (RIN 3150-AI78; NRC-2009-0558)

On December 24, 2013, the NRC published a document in the *Federal Register* ([78 FR 77606](#)) that makes available the NRC staff's response to public comments on a draft regulatory basis for a proposed rule that would revise the security requirements for storing spent nuclear fuel (SNF) in an independent spent fuel storage installation, and for storing SNF and/or high-level radioactive waste in a monitored retrievable storage installation.

List of Approved Spent Fuel Storage Casks: HI-STORM 100 Cask System; Amendment No. 9: Direct Final Rule; Correction and Delay of Effective Date; Proposed Rule; Correction and Extension of Comment Period; 10 CFR Part 72 (RIN3150-AJ12; NRC-2012-0052)

On December 26, 2013, the NRC published a document in the *Federal Register* ([78 FR 78165](#)) correcting and delaying the effective date of a direct final rule that appeared in the *Federal Register* on December 6, 2013 ([78 FR 73379](#)). The direct final rule amends the NRC's spent fuel storage regulations by revising the Holtec International HI-STORM 100 Cask System listing within the "List of Approved Spent Fuel Storage Casks" to include Amendment No. 9 to Certificate of Compliance (CoC) No. 1014. This action is necessary to correct the NRC's Agencywide Documents Access and Management System (ADAMS) accession numbers for the CoC, the safety evaluation report (SER), and the ADAMS document package containing the CoC, SER, and the Technical Specifications. Also on December 26, 2013, the NRC published a correction ([FR 78 78285](#)) to the companion proposed rule ([78 FR 73456, December 6, 2013](#)) to extend the public comment period to January 27, 2014.
