SUBJECT: SUMMARY OF THE DECEMBER 5, 2013, CATEGORY 2 MEETING  
REGARDING THE NATIONAL FIRE PROTECTION ASSOCIATION  
STANDARD 805 FREQUENTLY ASKED QUESTION PROCESS

On December 5, 2013, the U.S. Nuclear Regulatory Commission (NRC) staff held a meeting with stakeholders and the public to discuss Frequently Asked Questions (FAQs) at plants that are adopting National Fire Protection Association Standard 805 (NFPA 805).

Industry stakeholders and the NRC staff discussed the list of currently open FAQs. Industry representatives stated that comments from the NRC on FAQ 13-0068, which deals with the NFPA 805 license condition, had been received. Further discussion of the FAQ was delayed until the next FAQ meeting, to allow time for the comments to be reviewed and resolved.

Industry stakeholders stated that open FAQ 12-0061, which deals with the plant change process, and language used in license amendment requests and subsequent safety evaluations needs to be aligned with regard to evaluating the risk of proposed plant changes after transition to NFPA 805. The industry proposed a separate, face-to-face meeting to discuss the specific issue. The NRC staff agreed to having the separate meeting and working with industry representatives to schedule it.

There were no new FAQs introduced or discussed at the meeting. There were no public comments provided during the meeting.

The NRC staff and stakeholders agreed that the next FAQ meeting would take place on January 9, 2014 via teleconference.
