Dear Mr. Killingsworth:

Enclosed is Amendment No. 43 to your NRC Material License No. 21-03039-01 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

In addition, the NRC staff has reviewed the information provided and based on its review, the staff has concluded that all licensable radioactive material has been removed from your facilities located at 6867 E. Cass City Road, Cass City, Michigan; 1400 Howard Street, Detroit, Michigan; 1818 Third Avenue North, Escanaba, Michigan; 1680 Hartwick Pines Road, Grayling, Michigan; 19153 West Howard City-Edmore Road, Howard City, Michigan; 3101 Technology Blvd, Suite H, Lansing, Michigan; 38257 Mound Road, Sterling Heights, Michigan, and 2127 11th Avenue, Port Huron, Michigan. Therefore, we have authorized the release of these locations for unrestricted use.

Please note that License Condition No. 11.B as it appeared on Amendment No. 42 has been removed from your license. You will need to submit an amendment request to the NRC to change your RSO.

Also, please note, as they appeared on License Amendment No. 42, License Condition No. 15, regarding the use of gauges at temporary job sites, License Condition No. 20, regarding the decommissioning financial assurance requirement, and License Condition Nos. 22.A and 22.B, regarding the use of unshielded sealed sources more than three feet below the surface, were removed in accordance with NRC policy.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy


