SUMMARY
In order to change the RSO on this license and the AUs as requested, we will need the following information:

1. We cannot approve Dr. Courtois as RSO because your letter and attached documents do not support your request with respect to compliance with 10 CFR 35.50(c)(2), 35.50(d) and 35.50(e), for materials in 10 CFR 35.300 beyond iodine-131, i.e., materials in 10 CFR 35.396. Please submit appropriate information and a currently signed preceptor statement, limited to only the information requested in this correspondence, with your written response. Please do not submit resumes, CV's, or personal, proprietary information that we must protect, in accordance with 10 CFR 2.390, such as social security numbers, dates of birth, home addresses or phone numbers, patient records, college transcripts, etc. Please do not resubmit any documents you have already submitted. The guidance in Appendices B and D in NUREG 1556, Vol. 9, Rev. 2 may assist you also.
2. Heather Garrett, M.D.'s name appears with a middle initial of "B" in your letter dated 9/9/13 but her middle initial on the referenced license you enclosed is "V." Please advise us as to which middle initial for her is correct.
3. Dr. Purita Gupta's terminal degrees in your letter dated 9/9/13 are shown as "M.D., Ph.D." However, the referenced license you enclosed shows Dr. Gupta's terminal degree as "M.D." only. Please advise us as to which terminal degree(s) is or are correct.

4. Your letter dated 9/9/13 included an attached letter addressed to Scott Austermann of Progress West from a consultant, Mark Beanblossom. However, no explanation for the inclusion of this non-essential letter was provided and no direction was given to us in your letter for a specific point of contact. Please refrain from enclosing non-essential documents with amendment request correspondence but please always provide the name, telephone number, fax number and email address of at least one knowledgeable person for each licensing request you make in the future. This information will greatly help us to help you also.
5. We will now need to obtain one total possession limit, including your possession limit for iodine-131, for your authorization for materials in 10 CFR 35.300 in Subitem No. 8.C. This Subitem currently reads "As needed, not to exceed 300 millicuries of iodine-131." Your possession limit should be realistic for your needs and accommodate growth and waste streams. Please advise us as to what your new total possession limit for this authorization should be.
6. We will be deleting condition no. 13 from your license in the pending amendment, when it is issued, because it is no longer necessary for your license.
7. Please be reminded of the provisions in 10 CFR 30.9(a), "Completeness and accuracy of information,"..."(a) Information provided to the Commission by an applicant for a license or by a licensee or information required by statute or by the Commission's regulations, orders, or license conditions to be maintained by the applicant or the licensee shall be complete and accurate in all material respects."

This record also refers to the telephone conversations between Thomas Moenster and me and Scott Austermann and me on December 12, 2013, concerning the above matters, in part.
