Dear Dr. Arraiza:

This correspondence is in reference to your letter dated November 13, 2013, notifying us that you have added a stress room to your location of use. 10 CFR 35.13(e) states, in part, that a licensee shall apply and must receive a license amendment before it adds to or changes the areas of use identified on the license, **except for areas of use where byproduct material is used only in accordance with either 35.100 or 35.200**. Although an amendment is not needed, 10 CFR 35.14(b)(5) requires that you notify the NRC of such changes.

In accordance with 10 CFR 35.14(b)(5), your letter dated November 13, 2013 is accepted as notification that you have added to or changed the areas of use identified on your license where byproduct materials are used in accordance with either 35.100 or 35.200.

The NRC's Safety Culture Policy Statement became effective in June 2011.
