The Board held an evidentiary hearing on January 6 through 8, 2014. This Order memorializes directions given during that hearing.

Proposed transcript corrections are due ten days after the final transcript has been filed. Thereafter, each party has five days to file objections to any proposed transcript correction.

Proposed findings of fact and conclusions of law will be considered timely if filed on or before February 7, 2014. The NRC Staff and Intervenors may submit, no later than February 12, 2014, a brief memo, no longer than five pages, in response to any license condition proposed by Nuclear Innovation North America, LLC (NINA). The Board will consider a brief response by NINA if filed on or before February 18, 2014.
