GENERAL ASSIGNMENT, CONVEYANCE AND BILL OF SALE

THIS GENERAL ASSIGNMENT, CONVEYANCE AND BILL OF SALE (this "Bill of Sale") is made and entered into effective as of October 1, 2013, by and among on the one hand **PORTER PHYSICIAN SERVICES, LLC**, a Delaware limited liability company ("Buyer"), and on the other hand **NORTHWEST INDIANA CARDIOVASCULAR PHYSICIANS, P.C.**, an Indiana professional corporation ("NICP"), **NORTHWEST INDIANA CARDIOVASCULAR PHYSICIANS MANAGEMENT, INC.**, an Indiana corporation ("NICPM," and, collectively with NICP, the "Seller"), and their respective shareholders. Seller is hereinafter sometimes referred to as "Assignor." Buyer is hereinafter sometimes referred to as "Assignee."

This Bill of Sale is being delivered pursuant to that certain Asset Purchase Agreement (the "Purchase Agreement") by and among Buyer, Seller, and their Owners, and is subject to all of the terms and conditions thereof. Assignor hereby constitutes and appoints Assignee its true and lawful attorney, with full power of substitution, in the name of Assignor or otherwise, and on behalf and for the benefit of Assignee: (a) to demand and receive from time to time any and all of the Assets; (b) to give receipts and releases for or in respect of the same or any part thereof; (c) to institute and prosecute, from time to time, in the name of Assignor or otherwise, any and all actions, suits and proceedings which Assignee deems proper to collect, assert or enforce any claim, title, right, debt, note or actions, suits or proceedings in respect to the Assets; and (d) to execute such other documents and take such other action as may be necessary from time to time to carry out this Bill of Sale. Assignor hereby declares that the foregoing powers are coupled with an interest and shall be irrevocable.

Assignor covenants and agrees that it will at any time and from time to time do, execute, acknowledge and deliver any and all other acts, deeds, assignments, transfers, conveyances, powers of attorney or other instruments that Assignee reasonably deems necessary or proper to carry out the assignment and conveyance intended to be made hereunder.

This Bill of Sale shall be binding upon and inure to the benefit of Assignor and Assignee and their successors and assigns.
