The following additional information is needed to review your request to terminate your NRC license.

1. Please confirm that the only radionuclides you used were cesium-137 and americium-241 sealed sources in moisture/density gauges.
2. Please specify the date when the moisture/density gauges were returned to Troxler for disposal.
3. Our inspection reports indicated that you had three Troxler moisture/density gauges. Please submit leak test results and information (such as disposal/transfer records) for the Troxler 3411-B, serial 10217, moisture/density gauge.
4. The leak test results for the Troxler model 3440, serial 17246, were performed on September 21, 2012. Please submit a copy of the most recent leak test results to show the sealed sources were not leaking when the sources were returned to Troxler for disposal.
5. If you had a history of leaking sealed sources please provide information that includes the isotope, amount of leakage, contamination of other areas or personnel, description of the cleanup, and disposition of the source(s). If you did not have any history of leaking sealed sources please state so.
6. Please submit a copy of the acknowledgement letter that the radioactive materials were received by the company (Troxler) where the gauges were shipped for transfer/disposal.

Please send a facsimile (630- 515-1078) of your response to the above within 14 days and state, Response to Control 582634. Please include a cover letter on company letterhead, dated and signed (signed by an individual who is authorized to sign official documents on behalf of the licensee) with your response letter.
