Dear Mr. Kanwar:

This is in reference to your application dated December 10, 2013 requesting to renew Nuclear Regulatory Commission License No. 06-30865-01. In order to continue our review, we need the following additional information:

1. As stated in the notice of expiration which was sent to you, we reserve the right to request a complete, up-to-date application in cases where licenses have been amended frequently or are supported by a large number of fragmented or disjointed documents. It has been ten years since your original application. We have reviewed your submission and existing license and request that you submit a single, complete application using NUREG-1556, Volume 18, "Consolidated Guidance About Materials Licenses, Program-Specific Guidance About Service Provider Licenses". Refer to Section 8, Contents of an Application. For each item there is a Response from Applicant. Includes your response to each item in your submitted renewal application. Please note for item 8.10.6, you should submit the PL Medical emergency procedures for all likely scenarios as part of your renewal application.
2. Your application should have been signed by a management representative rather than the radiation safety officer. Please submit a letter signed by a management representative indicating that management has reviewed the application and concurs in the statements and representations contained therein. Note also that a management representative should sign all future correspondence that requests a change in your license.
