My Item 10 statement was

Licensed material may be used or stored at the licensee's facilities on Aberdeen Proving Ground, Maryland; 22D Chemical Battalion (Technical Escort), Aberdeen Proving Ground, Maryland; 110TH Chemical Battalion (Technical Escort), Joint Base Lewis-McChord, Washington; CBRNE Analytical and Remediation Activity facilities on Aberdeen Proving Ground, Maryland and Pine Bluff Arsenal, Arkansas and at temporary job sites of the licensee anywhere in the United States.

The first part of this, " Licensed material may be used or stored at the licensee's facilities on Aberdeen Proving Ground" was intended to allow storage in the area controlled by the NDT.
