Dear Mr. Jankovich,

As you know, we are currently licensed to operate out of Teaneck, New Jersey and Yonkers, New York. Due to commercial considerations, we have decided to close our Yonkers facility and open an identical receiving and distribution operation in Farmingdale, New York. Other than a slight difference in the size of the warehouse, an increase to 850 curies possessed at any one time, and its physical location, all other conditions and stipulations of our existing Distribution License and Device Registration Certificate remain unchanged.

Our New York State Possession License (C2989) covering the Yonkers facility has been changed to show the Farmingdale facility instead of the Yonkers one. For the sake of expedience, a copy of the amended license has been forwarded to you by email with an email copy of this letter.

Based on the above, we respectfully request that our Device Registration be amended to remove the Yonkers location and to show MEPROLIGHT, Inc. (170-20 Central Avenue, Farmingdale, New York, 11735) as an additional distributor. We have also requested from Ms. Shirley Xu that an appropriate change be made to our Distribution License.

Possession incident to distribution of self-luminous gun and archery sights manufactured by Meprolight, Inc., to persons exempt from the requirements for a license, pursuant to the United States Nuclear Regulatory Commission (USNRC) License No. 31-23902-01E.

10. A. The Radiation Safety Officer (RSO) for this License is Bradley Fisher.
- B. Licensed material shall be used by, or under the supervision of the Radiation Safety Officer. If this person leaves your employ or discontinues responsibility for overseeing your radiation protection program, you must contact the Department within thirty (30) days and designate a new Radiation Safety Officer.

11. Except as specifically provided otherwise in this License, the licensee shall conduct its program in accordance with the statements, representation and procedures contained in the documents, including any enclosures, listed below. The Department's Regulations shall govern, unless the statements, representation and procedures in the licensee's application and correspondence are more restrictive than the Regulations.
  - A. License Number 31-23902-01E issued by the USNRC, expiration date March 31, 2021.
  - B. License Renewal Application dated March 22, 2007, signed by Bradley Fisher, with attachments.
  - C. License Renewal Request dated November 9, 2009, signed by Bradley Fisher, with attachments.
  - D. License Renewal Request dated November 16, 2012, signed by Bradley Fisher.
  - E. Letters dated October 3, 2013, and November 13, 2013, signed by Bradley Fisher, with attachment.
12. Licensed material shall be stored and used at the licensee's installation located at the address indicated in Condition 2, above.
13. The licensee shall not accept any shipment of electron tubes and related devices from the manufacturer unless it is accompanied by the manufacturer's certification that it has been tested and found to be free of radioactive material contamination.
14. The licensee shall conduct a physical inventory every six (6) months to account for all electron tubes and related devices received and possessed under the License. The records of the inventories shall be maintained for three (3) years from the date of the inventory for inspection by the Department, and shall include the quantities and kinds of licensed material, manufacturer's name and model number, location of the electron tubes and related devices, the date of the inventory, and the name of the person who performed it.
15. Electron tubes and related devices containing licensed material that are found to be damaged, or which cannot otherwise be distributed, shall be returned to the manufacturer.

16. A. The licensee shall maintain a current copy of its USNRC License No. 31-23902-01E on file with the Department. A copy of each amendment to that license shall be submitted to the Department within fifteen (15) days of its receipt by the licensee.
- B. The licensee shall immediately notify the Department should its USNRC License No. 31-23902-01E be terminated or suspended.
17. The licensee shall submit complete decontamination procedures to the Department for approval ninety (90) days prior to the termination of authorized operations involving radioactive material in controlled areas and/or vacating installations pursuant to 12 NYCRR 38, section 38.23.
18. The licensee shall submit full information on any proposed change of ownership or control of licensed premises at least 90 days prior to the proposed action.
