Good Morning Mr. Schmitt -

Please note that beside the NRC licensees 07-30963-01 (possession license) and 07-03963-02G (distribution license), Montesino has an active Sealed Source and Device Registration Certificate with the NRC (NR-1193-D-101-G). Please also note that Ms. Ullrich, located in the NRC Region I office, handles the two licenses. I am the person, located at NRC Headquarters, who handles the Registration Certificate. As Betsy mentioned in her email to Adam Smith on September 12, 2013, our office (i.e., NRC HQ), used your September 12, 2013, letter addressed to Ms. Kotzalas, to process the inactivation of your Registration Certificate. Please note that the information which Adam provided to Betsy in Form 314 (email dated November 13, 2013) is related to License No. 07-30963-01; however, it is not the information which we need to inactivate Montesino's Registration Certificate NR-1193-D-101-G. Therefore, in order to inactivate Montesino's Registration Certificate, you need to respond to the questions stated in my email dated December 17, 2013.

Mr. Schmitt-

Your letter dated, September 12, 2013 informed us that Montesino Technologies, Inc. will not renew licenses 07-30963-01 and 07-039-63-02G and that Mr. Adam Smith will contact us. Since Mr. Smith has not contacted us yet, please note that in order to inactive your Registration Certificate NR-1193-D-101-G you need to provide the following information:

1. The total number of the products sold and the number of products still in use.
2. The services (including source replacement and availability) Montesino Technologies, Inc. will still provide to users of the product or the identification of an entity that will provide services.
3. A commitment that Montesino Technologies, Inc will no longer commercially distribute the product
4. Confirmation that no changes were made to the product since its initial registration in 2003. If changes have been made, please provide the information to be incorporated into the inactivated certificate.

Please provide the information stated above within 30-days of the day of this email.
