RAI, Need for Decommissioning Funding Plan

Discussion: I discussed with Mr. Goodison that other commands are using the same building for waste disposal. The material must be located in a space specifically designated for their material and not other commands. Mr. Goodison will send in a schematic to show the specific area in the building where there material may be located.

Second, I discussed the need to perform the recalculation of the decommissioning funding plan before issuance of the additional area. The new calculation will need to incorporate this area. Also, the Statement of Intent needs to be inclusive of this new area.

Third, we discusses that the Edgewood Area of the Aberdeen Proving Ground is now called Aberdeen Proving Ground – South and the license should reflect this with this amendment.

Action Required: RSO to complete the recalculation of the decommissioning funding plan and to submit a schematic with the location inside the building and the location of the building in Aberdeen Proving Ground – North.
