MEMORANDUM AND ORDER

(Requesting Update on Issuance Date for  
Final Supplemental Environmental Impact Statement)

By letter dated November 4, 2013, the NRC staff advised the Licensing Board that the impact of the one-week federal government shutdown during October 2013 on its final supplemental environmental impact statement (FSEIS) review schedule would be a one-month delay in the issuance date, i.e., until February 28, 2014. See Letter from Emily Monteith, NRC Staff Counsel, to Licensing Board (Nov. 4, 2013). With that revised issuance date a little more than a month away, the Licensing Board requests that on or before Friday, January 24, 2014, the staff provide an update on its review schedule by advising the Board whether it currently

anticipates FSEIS issuance on February 28, 2014, and, if not, what is the revised issuance date.
