Dear Mr. Fishman:

We have reviewed your application dated July 22, 2013. We have determined that additional information is needed to complete our review. Please respond to the following.

- 1. Provide a list of manufacturers and models for all of the devices that you requested.
- 2. Provide the maximum activities for Iron-55 and Cadmium-109 sealed sources that you requested.
- 3. Provide a description of the use of the devices containing Iron-55 and Cadmium-109 sealed sources.
- 4. With regarding the future RSO, you selected "yes" for "Other"; however, the explanation was not found in the application. Please confirm that before being named as the RSO, future RSOs will have successfully completed the training described in Criteria in the section entitled "Individual(s) Responsible for Radiation Safety Program and Their Training and Experience Radiation Safety Officer" in NUREG-1556, Vol. 4, dated October 1998, and within 30 days of naming a new RSO, the licensee will submit the new RSO's name to NRC to include in its license.
- The licensee requested to perform the sealed source leak test; however, the provided information was not adequate. Please confirm that the licensee will implement the model leak test program published in Appendix M to NUREG-1556, Volume 4 dated October 1998.

NUREG-1556, Volume 4, dated October 1998 provides the program specific guidance about fixed gauge licenses. NUREG-1556, Volume 4 is available on the NRC website at http://www.nrc.gov/reading-rm/doc-collections/nuregs/staff/sr1556/v4/.

We request that you submit your response in writing by November 18, 2013. Your response must be **dated** and **signed** by an authorized personnel and please refer to Mail Control No. 581408 to facilitate proper handling in our office. We will resume the review upon receipt of your response.
