Issuance of Callaway NFPA 805 License Amendment

On January 13, 2014, staff approved the Callaway Plant, Unit 1, license amendment to transition to National Fire Protection Association Standard 805 (NFPA 805). This is the third non-pilot plant to transition to the risk-informed, performance-based fire protection rule. As part of the implementation of NFPA 805, the licensee is making safety improvements to reduce the risk associated with a fire.
