Dear Sir or Madam:

On October 1, 2013, the NRC staff issued Reference 1, and Reference 2 provided responses to the RAIs on Recommendation 9.3, Emergency Preparedness focused on Communications and Staffing. In the response to Issue 1 Entergy Operations, Inc. stated the following:

Existing guidance contained in the Arkansas Nuclear One (ANO) Emergency Plan, Arkansas Comprehensive Emergency Management Plan, Arkansas Aviation Operations Plan, and Letters of Agreement (LOAs) is adequate to ensure State and local resources (including helicopters) would be used, if available, to transport Emergency Response Organization (ERO) personnel to the site following a Beyond Design Basis External Event (BDBEE); therefore, additional LOAs to perform this function are not necessary.

This response is being clarified as follows:

Existing guidance contained in the ANO Emergency Plan, Arkansas Comprehensive Emergency Management Plan, Arkansas Aviation Operations Plan, and LOAs is adequate to ensure State and local resources (including helicopters) could be used to transport ERO personnel to the site following a BDBEE; therefore, additional LOAs to perform this function are not necessary.
