Happy New Year. I hope that everyone is staying warm during these chilly days of winter. Summer is only 165 days away. Think warm thoughts.

You may have seen a lot of recent news and speculation regarding KI purchases by the Department of Health and Human Services and unfolding events at Fukushima. I want to let you know that these HHS purchases are for the NRC KI program and are not linked to anything else. HHS is the purchasing office for the NRC KI orders. Using HHS's procurement office enable us to leverage the buying power of the US government.

HHS has placed orders with the vendor, Anbex, for 65 mg tablets that are made by Recip AB from Sweden. The KI tablets are made "to order" ensuring that the tablets that are shipped have the longest possible shelf life. We have been told to expect receipt at HHS in mid-April and HHS will ship to the States shortly after that. The tablets should be delivered by the end of April. If this changes, I will let you know!
