Discussed 2 issues with their request to add 2 physicians as authorized users on License No. 32-04054-04, Won Song, M.D. and Sheldon Jensen, M.D. 1) Letter dated 10/15/2013 requested Dr. Song be authorized for 35.100, 35.200, 35.300, and 35.500. License No. 32-04054-04 does not list authorization for 10 CFR 35.500. CPT Hall requested that we remove their request to add 10 CFR 35.500 authorization and we will process the amendment to add him for 35.100, 35.200 and 35.300. 2) Letter dated 10/15/2013 also requests Dr. Jensen be authorized for 35.100, 35.200, and 35.300 sodium iodide I-131 both less than and greater than 33 mCi and for parenteral administration of any beta or photon emitting radionuclide with photon energy less than 150 keV. Supporting information [NRC Form 313 (AUT) contained evidence of clinical cases involving sodium iodide I-131 only. CPT Hall requested that we remove their request to authorize Dr. Jensen for 10 CFR 35.300 to include parenteral administration of any beta or photon emitting radionuclide with photon energies less than 150 keV and authorize him for 10 CFR 35.100, 35.200, and 35.300 sodium iodide I-131 in quantities less than or greater than 33 mCi.
