**Discussion:** All documentation submitted by the licensee indicates that Mr. Feng's name is "Wenzheng" except the license from Columbia University/New York Presbyterian Hospital which lists him as "Wengheng" Feng, an authorized medical physicist. I contacted Maxwell Amuaro, Ph.D., RSO for Columbia University/New York Presbyterian Hospital's license and confirmed that Mr. Feng's name was misspelled on the license and that the "g" should have been a "z."

**Action Required:** Proceed with the amendment to add Wenzheng Feng as an AMP.
