

This update reflects the AREVA Group internal reorganization presented in Reference (2) as it affects AES and the NRC consent provided in Reference (3).

Other Eagle Rock Enrichment Facility (EREF) License Documents affected by these changes, namely the Safety Analysis Report (SAR), and the Fundamental Nuclear Material Control Plan (FNMCP), will be updated in the next revision of the License Basis Documents.
