Dear Administrative Judges:

In its Order dated January 8, 2009, the Atomic Safety and Licensing Board ("Board") directed the NRC staff ("Staff"), commencing on January 15, 2009, to tender each month "a short report advising as to whether the estimated dates for issuance of the final [Safety Evaluation Report ('SER')] (predicted for summer/fall of 2009) and final [environmental review document] (predicted for December of 2009) have changed or become more definitive."

On January 2, 2013, the Staff informed the Board and the parties of the public availability of the SER. The SER can be accessed electronically via ADAMS Accession Number ML103470470.

The Staff still estimates that it will be able to issue the final environmental review document by the end of March 2014.

The Staff will tender its next monthly status report by March 16, 2014.
