This letter refers to your request for renewal of special nuclear materials (SNM) license SNM-2014, transmitted by letter dated August 23, 2012 (Agencywide Documents Access and Management System [ADAMS] Accession No. ML12278A337), and supplemented by submittals dated July 1, 2013 (ADAMS Accession No. ML13189A033), and January 15, 2014 (ADAMS Accession No. ML14036A010). The U.S. Nuclear Regulatory Commission (NRC) staff has completed a Safety Evaluation Report documenting its review of the application and its findings regarding the renewal of the subject license. Pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Part 70, SNM-2014 is renewed and set to expire on September 30, 2017.

This 10 CFR Part 70 license is issued following the preparation and publication of an Environmental Assessment (EA) and a Finding of No Significant Impact (FONSI) related to this action. The EA and FONSI were published in the *Federal Register* (FR) on December 17, 2013 (78 FR 76328).

Upon issuance of this license, Technical Assignment Control No. L33242 will be closed.
