Re: Notice of Closing of Transaction


Dear Ms. Abogunde:

I am writing on behalf of our client, Community Health Systems, Inc. (“CHSI”), in follow up to previous correspondence with your office. A copy of the cover letter prefacing that correspondence is enclosed for your reference as Exhibit A. Please be advised that effective as of **January 27, 2014** (the “Effective Date”), CHSI and Health Management Associates, Inc. (“HMA”) closed a transaction that resulted in the merger of HMA with an indirect, wholly-owned subsidiary of CHSI (the “Transaction”). As a result, following the closing of the Transaction, HMA ceased to be a publicly-traded corporation and became an indirect, wholly-owned subsidiary of CHSI. Furthermore, as of the Effective Date, CHSI became the ultimate parent company of each of the HMA subsidiaries, including the subsidiaries that own and operate health care facilities in West Virginia. For further detail regarding the Transaction, please refer to Exhibit A.
