This letter refers to your license amendment request dated November 14, 2013, to change your Radiation Safety Officer from Dennis Ferguson, M.D. to Stewart E. Bober, M.D. We also confirmed with your Radiology Operations Manager that you want to have Dr. Ferguson removed as an authorized user from your license. Therefore, we have also deleted Dr. Ferguson as an authorized user. Enclosed with this letter is the amended license.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
