This letter refers to an investigation conducted by the U.S. Nuclear Regulatory Commission (NRC), Office of Investigations (OI) to determine if a former Source Inspector and independent contractor with Procurement Services Consulting, Inc. (PSC), which was contracted by Chicago Bridge and Iron (CB&I) to provide Quality Assurance oversight at Cives Steel Company (Cives) was discriminated against for raising safety concerns. Based upon the evidence developed during the investigation, the NRC did not substantiate that discrimination occurred in this instance.
