Dear Mr. White:

Enclosed is Amendment No. 08 renewing your NRC Material License No. 13-26511-01 in accordance with your request.

Please note that License Condition No. 11.B as it appeared on Amendment No. 07 has been removed from your license. You will need to submit an amendment request to the NRC to change your RSO. Also, License Condition Nos. 21, 22, and 23 as they appeared on Amendment No. 07 have been removed because they are now a part of your license application.

In addition, please note that, in accordance with NRC policy, we have added License Condition 13.F regarding leak testing records, License Condition 18 regarding the initial mounting of gauges, License Conditions 19.A and 19.B regarding maintenance of the gauges, License Condition 23 regarding changes made to the gauges, and License Condition 24 regarding the transportation of gauges. Also, License Condition 20, as it appeared on Amendment No. 07 regarding testing of the shutter, has been modified and is now License Conditions 16.A and 16.B.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. 
