Dear Mr. Laughlin:

This letter confirms the U.S. Nuclear Regulatory Commission's (NRC's) authorization to introduce uranium hexafluoride into Cascade 4.10 at the Louisiana Energy Services (LES), URENCO USA Facility located in Eunice, New Mexico. This authorization is pursuant to the provisions of Title 10 of the *Code of Federal Regulations* (10 CFR) Part 70, Paragraph 70.32(k) and 10 CFR 40.41(g) that states, "No person may commence operation of a uranium enrichment facility until the Commission verifies through inspection that the facility has been constructed in accordance with the requirements of the license."

This NRC authorization is based on the results of construction and quality assurance inspections of various aspects of Assay 4 in Separation Building Module -1003, as described in the inspection reports listed in the Enclosure. The NRC staff determined that the systems, structures, and components designed to support safe operation of Cascade 4.10, including feed and withdrawal stations, were constructed in accordance with the requirements of your license. Specifically, our inspections provided: (1) reasonable assurance that the design, construction, and implementation of items relied on for safety (IROFS) will protect against natural phenomena and the consequences of potential accidents, (2) verification that the Quality Assurance Program was adequately implemented during construction, and (3) verification that the construction of the IROFS was completed in accordance with the documents comprising the license and the Integrated Safety Analysis.

The publically available inspection reports that describe the construction and quality assurance inspections of Cascade 4.10 are accessible through the NRC's Public Document Room, or from the Publicly Available Records System (PARS) component of NRC's Agencywide Documents Access and Management System (ADAMS) at http://www.nrc.gov/reading-rm/adams.htm using the accession numbers listed in the Enclosure.

Please note that this authorization does not apply to any Cascades other than Cascade 4.10, and it does not apply to processes or components associated with future phases of facility operations.
