AT THIS TIME THERE ARE ONLY TWO SOUTHWEST X-RAY EMPLOYEES. AS I HAVE MENTIONED BEFORE, KURT AND I HAVE REVIEWED THE VIOLATION SEVERAL TIMES. WE HAVE IMPLEMENTED A BETTER VERBAL POLICY. I MAKE SURE KURT STOPS RADIOGRAPHIC OPERATION BEFORE I LEAVE THE WORK AREA. KURT MAKE SURE I AM PRESENT BEFORE ANY RADIOGRAPHIC OPERATION BEGIN. AS MENTIONED IN THE RESPONSE LETTER DATED 12-13-13. A COPY OF THE FINAL DETERMINATION WILL BE ADDED TO SOUTHWEST X-RAY'S O&E MANUAL, IN THE USEFUL INFORMATION SECTION.

AT THIS TIME SOUTHWEST HAS NO INTENTION OF HIRING ANY NEW EMPLOYEE. BUT WHEN IT DOES HAPPEN, ALL THE RULES & REGULATION OF THE NRC WILL BE FOLLOWED. EVERY SOUTHWEST X-RAY EMPLOYEES WILL HAVE A THOROUGH UNDERSTANDING, OF ALL THE RULES & REGULATIONS.
