SUBJECT: SUMMARY OF FEBRUARY 27, 2014, PUBLIC MEETING TO DISCUSS  
THE CONSTRUCTION INSPECTION PROGRAM

On February 27, 2014, the U.S. Nuclear Regulatory Commission (NRC) held a public meeting with members of the public to discuss the construction inspection program.

The NRC staff started the meeting by discussing how the NRC will be incorporating safety culture common language into the Reactor Oversight Process and the Construction Reactor Oversight Process (Agencywide Documents Access and Management System (ADAMS) Accession No. ML14056A343). During this presentation, the NRC staff indicated that a proposed revision to Inspection Manual Chapter (IMC) 0613, "Power Reactor Construction Inspection Reports," Appendix F, "Construction Cross-Cutting Components and Aspects," to incorporate safety culture common language would be issued for public comment. This document is available at ADAMS Accession No. ML14065A531. Comments submitted within 30 days of the date of this summary to [thomas.kozak@nrc.gov](mailto:thomas.kozak@nrc.gov) will be considered for inclusion in IMC 0613, Appendix F.

Next, the NRC staff described the procedures which have and are being developed for the Initial Test Program for the AP1000 (ADAMS Accession No. ML14056A259). The NRC staff continued by presenting information on the status of inspections and activities related to the AP1000 Design Acceptance Criteria (DAC) (ADAMS Accession No. ML14056A183). Next, the NRC staff discussed the lessons learned from the NRC inspections which have been completed thus far and then discussed the lessons learned from the inspections, tests, analyses, and acceptance criteria (ITAAC) closure notification reviews (ADAMS Accession No. ML14056A339). Lastly, the NRC staff discussed the self-assessments performed on the Part 52 processes, including licensing and post-combined license implementation. The NRC staff further discussed the action plans which were developed as a result of the self-assessments and the current status of each lesson (ADAMS Accession No. ML14056A244).
