Dear Mr. Miner:

I am responding to your letter dated December 6, 2013 (ACO 13-0054), requesting U.S. Nuclear Regulatory Commission (NRC) review and approval of a revision to Operations Security (OPSEC) Plan 331-06-161 for the American Centrifuge Plant (ACP). In your letter, you also informed that, effective November 21, 2013, Mr. Brian Kissinger was officially appointed the OPSEC Coordinator by the ACP's Security Manager. In this role, Mr. Kissinger will serve as the chair for the OPSEC Working Group.

The NRC staff, in coordination with the U.S. Department of Energy, Oak Ridge Office, has completed its review of the information provided in your request. The OPSEC Plan was reviewed during a routine classified matter inspection conducted on January 21-24, 2014, at the ACP in Piketon, Ohio. The NRC staff findings are documented in NRC Inspection Report number 07007004/2014201. Based on its review of the information provided and the inspection findings, the NRC staff has concluded that the OPSEC Plan is comprehensive and is in conformance with Nuclear Energy Institute's (NEI's) guidance document NEI-08-11. As such, the NRC staff determined that the revisions to the OPSEC Plan are acceptable and, therefore, are approved.

This action closes efforts under Technical Assignment Control number L34275.
