Please find enclosed Amendment Number 26 to NRC License Number 11-27680-01MD adding authorizations in Items 7.L., 9.L., and 9.M. on the license, and increasing your possession limit in item 8.L., as requested. Please note that if the procedure listed in Item 9.L. and M. (iii) is revised or modified, you must submit an amendment request with the updated procedure. An environmental assessment for this licensing action is not required since this action is categorically excluded under 10 CFR 51.22(c)(14)(xiii). Since the NRC also accepts a letter requesting amendment of an NRC license, the signatory for such a request should also be the licensee or certifying official rather than a consultant.

NRC will periodically inspect your radiation safety program. Failure to conduct your program according to NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC may result in enforcement action against you. This could include issuance of a notice of violation; imposition of a civil penalty; or an order suspending, modifying, or revoking your license as specified in the NRC Enforcement Policy.
