Michelle Kehoe, hired 4/2012, as an Associate Radiological Health Specialist. She has a B.S.and C.N.M.T. and several years' experience as nuclear medicine department manager.

Marc Sullivan began working for the Bureau on November 14, 2013 and not yet met the qualification requirements for a radioactive materials license reviewer or inspector. Mr. Sullivan will work as a Radiological Health Specialist Trainee for a period of two years before becoming fully qualified to work as a Senior Radiological Health Specialist. As part of his two year training he will be attending an in-house classroom training session covering the fundamentals of health physics. The conclusion of the classroom training will include a final written exam. We hope to supplement his in-house training with NRC-funded training as it becomes available. At a minimum he will apply for Fundamental Health Physics I, II, and III along with Licensing Procedures and Inspection Procedures.

He will also participate in reviewing simple license applications under the supervision of a senior level license reviewer. The types of licenses that he reviews will become progressively more complex as he gains the skills necessary to independently review less complex licenses. All licensing actions that he completes will be reviewed for completeness by the Chief of the Radioactive Materials Section and any deficiencies in his license review will be discussed with him. By the end of the two year period Mr. Sullivan will be expected to independently review portable gauge license applications and 10 CFR 35.100 and 35.200 license applications.

Over the course of the two year period, Mr. Sullivan will also accompany senior level inspectors in order to gain experience in performing inspections of portable gauge licenses and smaller medical use licenses. By the end of the two years, he is expected to independently perform a routine inspection of a portable gauge license.

Michelle Kehoe, needs Brachytherapy & GammaKnife (2014) and Industrial Radiography (2014) & Security Concepts (2015) otherwise qualified for most RAM inspections.
