## SUBJECT: INTERNATIONAL CYCLOTRON, INC., HATO REY, PUERTO RICO SITE

Dear Dr. Kolodziej:

As of February 17, 2014, you have not conducted principal activities under your licenses for a period of 24 months. Therefore, in accordance with 10 CFR 30.36(d), within 60 days of that date (specifically, by April 18, 2014), you must notify the NRC in writing and begin decommissioning your facilities. If you cannot immediately begin decommissioning, you must notify the NRC in writing by April 18, 2014, and submit a decommissioning plan to the NRC within 12 months of the notification.

The NRC will conduct document reviews and inspections to verify that these actions regarding decommissioning take place as required. Should the actions not occur as required, the NRC intends to pursue enforcement actions in addition to the NRC Order Suspending Licensed Activities issued to International Cyclotron on December 19, 2011 (ML11353A417<sup>1</sup>).

Please reply by letter within 10 days with the following information:

- Progress in obtaining an acceptable financial assurance instrument,
- Plans for sale of the facility, and
- Intentions regarding commencement of decommissioning.
