Dear AAB Chief:

On behalf of the AREVA Inc. (AREVA), I would like to request a copy of the NRC's SecPop4.2.0 code and code documentation. I understand that the conditions for receiving this code are as follows:

1. AREVA understands that the above stated code is the result of work sponsored by an agency of the United States Government and recognizes that neither the United States Government nor any agency thereof, nor any of their employees makes any warranty, expressed or implied, or assumes any legal liability or responsibility for any third party's use, or the results of such use, or of any information, product, or process included in or calculated by this code, or represents that the use by such third party would not infringe privately-owned rights.
2. AREVA shall not release this code to any third party without obtaining prior written permission from the NRC, and the third party must also obtain in advance written permission from the NRC.
3. AREVA shall communicate any code errors to the NRC.
4. AREVA shall provide the NRC with any nonproprietary improvements or modifications made to this code.
5. AREVA shall notify the NRC any reactor safety problem which may be uncovered through the use of this code.
6. AREVA shall provide the NRC with a nonproprietary summary of any proprietary modifications made to this code, including a summary of the impact on representative code calculations.
7. AREVA shall identify its modified version of the NRC code with a somewhat different name (e.g., MACCS2- is a -modified version of the NRC's MACCS2 code).
8. AREVA is solely responsible for obtaining any assistance needed to implement or use this code.
9. Is AREVA a foreign entity (defined as an entity where 75 percent or more of the voting interest is owned by non-U.S. citizens)?






