HONEYWELL METROPOLIS WORKS EMERGENCY PREPAREDNESS
EXERCISE ON APRIL 30, 2014**

Dear Mr. Pritchett:

The U.S. Nuclear Regulatory Commission (NRC) routinely participates in licensees' emergency preparedness exercises to ensure that the NRC's Incident Response capabilities are effectively maintained, and to provide licensees an opportunity to exercise the interface with the NRC that may occur during the response to an incident at their sites. The purpose of this letter is to inform you of our intent to participate in the Honeywell Metropolis Works emergency preparedness exercise that is scheduled to occur on April 30, 2014, which was previously discussed with Barry Stephenson of your emergency preparedness staff.

Currently, the NRC intends to participate with a Base Team located at the Region II office in Atlanta, Georgia, and staffed for a response to a fuel facility incident. There will also be a limited participation onsite at your facility. There will be no participation by NRC Headquarters, except for the Headquarters Operations Officers. If our scope of participation changes, we will contact your emergency preparedness staff to discuss the changes. We will also be coordinating with your staff to schedule pre-exercise outreach discussions with our emergency response coordinators. These discussions further reinforce concepts related to NRC incident response activities.

In accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room, or from the Publicly Available Records (PARS) component of NRC's Agencywide Documents Access and Management System (ADAMS), accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html> (the Public Electronic Reading Room).
