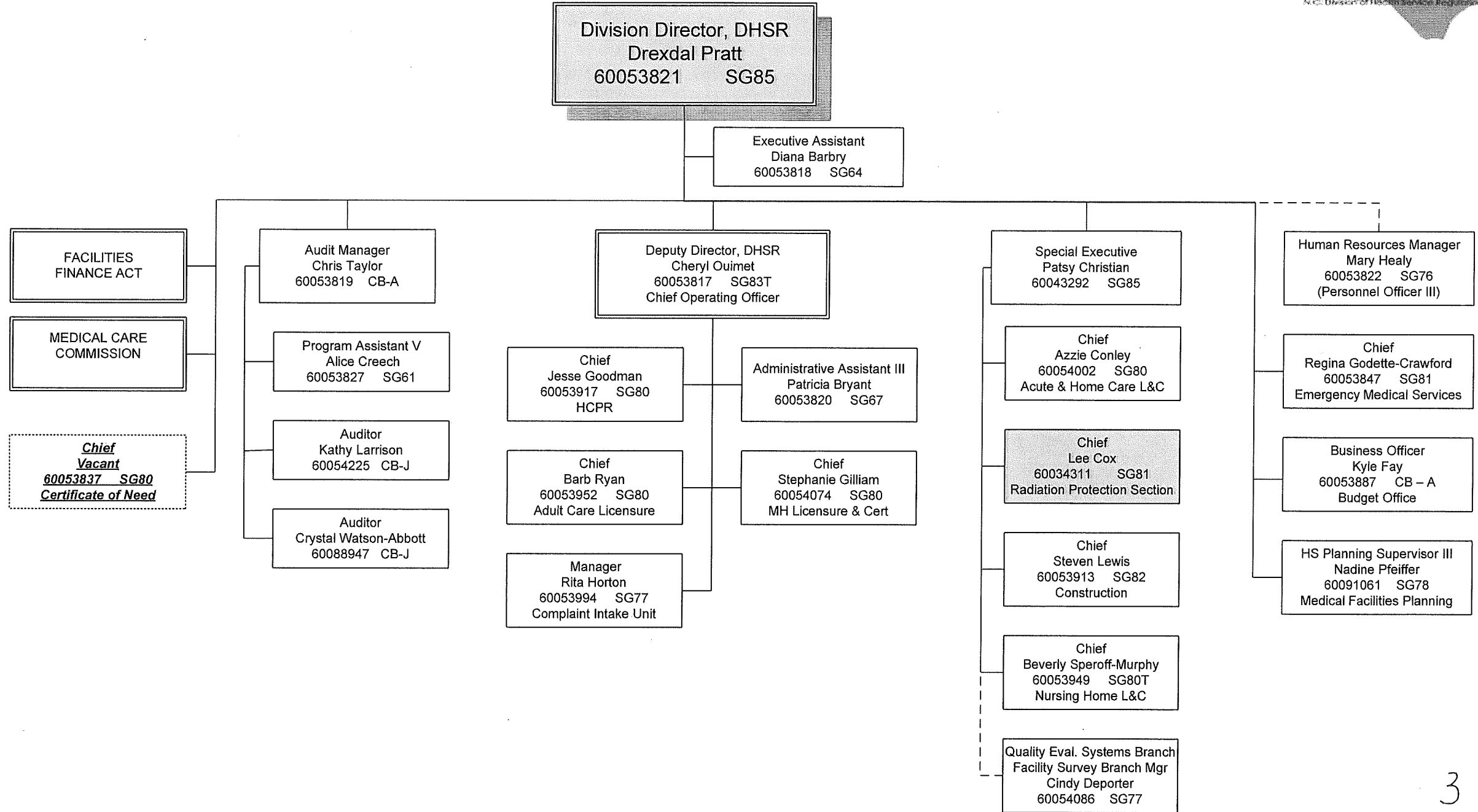

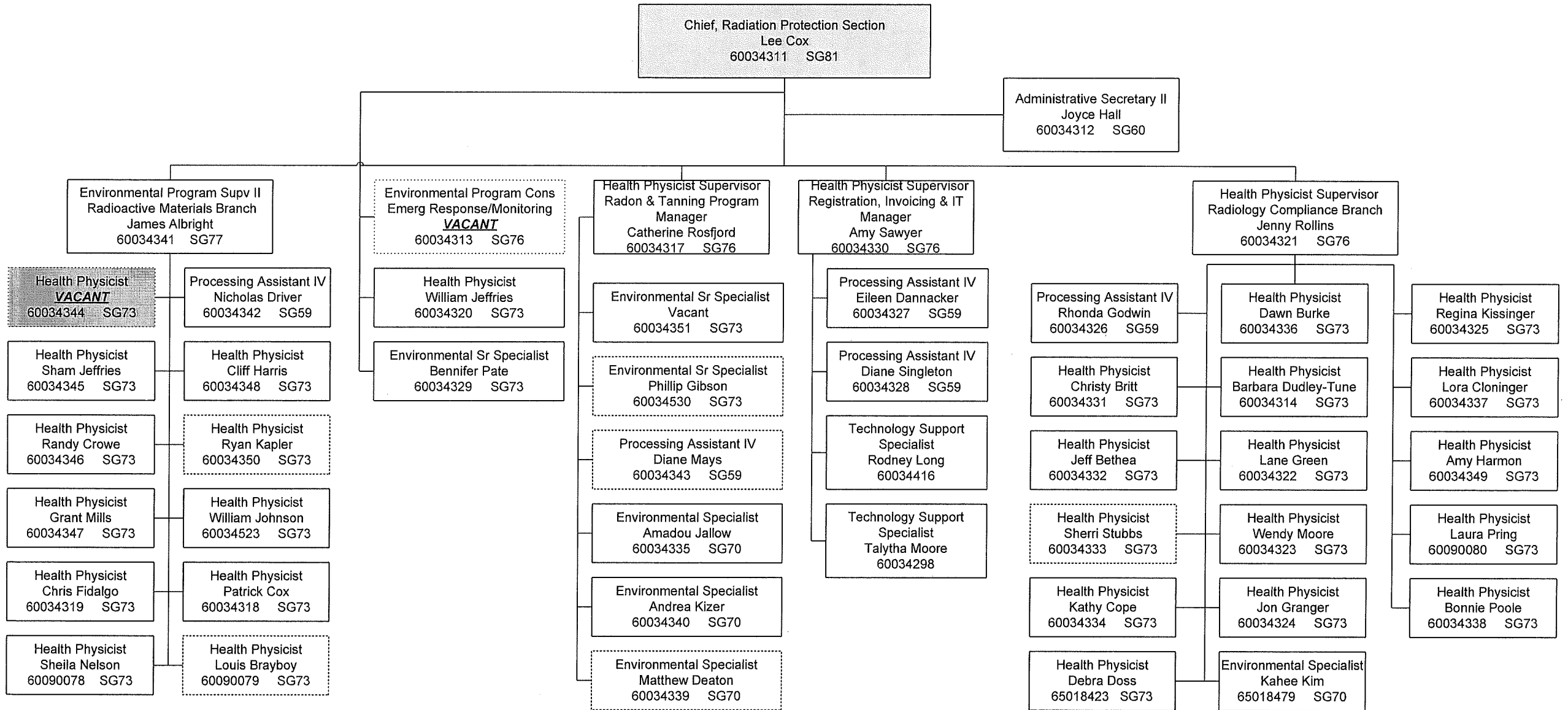
## DIVISION OF HEALTH SERVICE REGULATION DHSR Overall Structure
