SUBJECT: SUMMARY OF MARCH 2014 MEETING WITH NUCLEAR
ENERGY INSTITUTE/INDUSTRY TO DISCUSS REGULATORY
ISSUES AT THE INDUSTRY INITIATED FUEL CYCLE
OVERSIGHT CONFERENCE

The staff of the U.S. Nuclear Regulatory Commission (NRC) met with the fuel cycle industry and the Nuclear Energy Institute representatives in a multiday meeting on March 3, 5, and 6, 2014, in Atlanta, Georgia. The non-public portion of the meeting occurred on Monday, March 3, 2014, and the Category 2 public portion occurred on March 5 and 6, 2014, as described in the meeting announcement (Agencywide Documents Access and Management System Number ML14036A259). The purpose of this three day meeting was to discuss the drivers, status, flexibility, and path forward for a number of regulatory activities impacting fuel cycle facilities. The topics discussed during the meeting included the following items: Monday (closed meeting) – Cyber and Chemical Security; Wednesday (open meeting) – Cumulative Effects of Regulation, Corrective Action Program, and Acute Uranium, Dermal/Ocular Exposure; and Thursday (open meeting) – Part 21 Site Visits and Rulemaking, Part 40 Project Plan Path Forward, and Fuel Cycle Oversight Process.
