**NOTIFICATION OF UPCOMING UPDATE TO THE U.S. NUCLEAR REGULATORY
COMMISSION'S OPEN GOVERNMENT PLAN AND OPPORTUNITY TO PROVIDE INPUT
(FSME-14-029)**

Purpose: To provide notification of: 1) upcoming update to the U.S. Nuclear Regulatory Commission's (NRC) Open Government Plan; and 2) the opportunity for States to provide input for consideration in developing that update.*

Background: As an independent regulatory agency that prides itself on openness, NRC takes an active role in President Barack Obama's Open Government Initiative (<http://www.whitehouse.gov/open/about>), with its focus on open, accountable, and accessible government. The NRC has a long history of, and commitment to, transparency, participation, and collaboration in its regulatory activities. The NRC first published its Open Government Plan on April 7, 2010, and then issued a revision on June 7, 2010, to reflect feedback received. In April 2012, NRC updated the plan again.
