Subj: FEBRUARY UPDATE CONCERNING NAVY'S ALTERNATE SCHEDULE REQUEST FOR  
SUBMISSION OF FINAL STATUS SURVEY REPORTS ON 03 JUNE 2013

Under master material license No. 45-23645-01NA, in our letter of 03 June 2013, the Navy requested an alternate schedule of 31 October 2013 for submission of the final status survey reports involving licensed radioactive materials at Naval Research Laboratory Chesapeake Beach Detachment (NRLCBD) and at Naval Surface Warfare Center Dahlgren Division (NSWCDD). Additional information concerning this request was forwarded in our letters of 09 August 2013, 07 October 2013 and 30 October 2013 (which requested a new alternate schedule submission date of 31 October 2014). This letter provides an update on the status of this request.

Since the last update, the Navy has received the NSWCDD report from the contractor on 27 Jan 2014. The report is currently under review and is anticipated to be complete in the next few weeks. The contracting organization and the Navy continue to work with the contractor to provide this final status survey report along with the NRLCBD final status survey report. However, we are developing alternate plans for completing the reports if necessary. Both reports are still anticipated to be finalized and ready to submit by 31 October 2014. In the meantime, the Navy will continue to provide the NRC with written monthly updates.
