 Amendment No. 21 due to retirement

Dear DNMS Licensing Assistant:

Due to the retirement of Mr. Garmon B. Smith Jr, Radiation Safety Officer (RSO) for the Robert S. Kerr Environmental Research Center, U.S. Environmental Protection Agency, Ada, Oklahoma, we are requesting to amend our NRC Materials License 35-11581-02 to change the designated RSO to Mr. Anthony R. Lee. Amendment No. 21 renewing License No 35-11581-02 (Docket 030-09517) issued on February 3, 2014 lists Mr. Lee as an authorized user in condition 11. Mr. Lee has been an authorized user on this license since 1998. Amendment No. 21 lists Mr. Anthony R. Lee as an Alternate Radiation Safety Officer in conditions 32.A. (ML13241A532) and 32.B. (ML14022A119). Mr. Lee completed the 40-hour RSO training in March 2000 and was designated as the Alternate RSO in April 2000.

It is anticipated that the formal retirement date for Mr. Smith will be no later than April 3, 2014, therefore we request that the RSO listed on License No. 35-11581-02 be changed from Garmon B. Smith Jr to Anthony R. Lee effective April 4, 2014. Please inform us of any additional information or action that needs to be provided from the U.S. EPA to affect this requested change.
