BASES FOR PROPRIETARY DESIGNATION							
<p>Category A: Data/interpretations – The document includes information that is commercially sensitive and that has been held in confidence by Crow Butte. This information contains a process or method, including supporting data and analyses, that has been developed using significant expenditures of Crow Butte resources. The information reveals aspects of privately funded development plans or programs of commercial value to Crow Butte. The information, if used by a competitor, could reduce its expenditure of resources or improve its competitive position in the production of similar a product or service as Crow Butte.</p>							
<p>Category B: Confidential internal calculations and evaluations – The document includes information that is commercially sensitive and that has been held in confidence by Crow Butte. This information contains a process or method, including supporting data and analyses. If consultants and/or other businesses providing services in the electric/nuclear power industry were able to publicly obtain the information, they would be able to use it commercially for profit and avoid spending the large amount of money that Crow Butte was required to spend in preparation of the information in the design, manufacture, installation, assurance of quality, or licensing of a similar product.</p>							
<p>Category C: Cost data – The document includes information that is commercially sensitive and that has been held in confidence by Crow Butte. The information reveals cost/price information of Crow Butte and/or its suppliers. The information consists of commercial information and cost data that has commercial value and provides a competitive advantage to Cameco. Use of the information by a competitor would permit the competitor to significantly reduce its expenditures, in time or resources, to develop similar information. Use of the information by a vendor would give the vendor a competitive advantage in marketing its services to Crow Butte and its competitors.</p>
