The purpose of this contract modification is to exercise Option Year Two thereby extending the period of performance through March 26, 2015, and increasing the contract ceiling amount by \$200,310.00, from \$380,814.00 to \$581,124.00.

Accordingly, the following highlighted changes are hereby made:

- 1) Section **A.4 CONSIDERATION AND OBLIGATION—TASK ORDERS (AUG 2011)** paragraph (a) is deleted in its entirety and the following is substituted in-lieu thereof:

“(a) The total current estimated amount of this contract (ceiling) for the services ordered, delivered, and accepted under this contract is **\$581,124.00**. This ceiling includes the firm fixed line items portion of the contract with a ceiling amount of **\$26,364.00** and the delivery order line items with a ceiling amount of **\$554,760.00**.”

- 2) Section **F.2 PERIOD OF PERFORMANCE (AUG 2011) ALTERNATE IV (AUG 2011)** is deleted in its entirety and replaced with the following:

“The ordering period for this contract shall commence on **March 27, 2012** and will expire on **March 26, 2015**. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.) The term of this contract may be extended at the option of the Government for an additional **two** 1-year option periods.

**Option Period(s):**

**Option Year One: March 27, 2013 – March 26, 2014 EXERCISED**

**Option Year Two: March 27, 2014 – March 26, 2015 EXERCISED**

All other terms and conditions under this contract remain unchanged and fully enforceable.
