SUBJECT: SUMMARY OF MARCH 20, 2014, PUBLIC MEETING WITH
MITSUBISHI HEAVY INDUSTRIES, LTD. TO DISCUSS DESIGN
CERTIFICATION SAFETY EVALUATION CHAPTER STATUSES

On March 20, 2014, a Category 1 public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) and Mitsubishi Heavy Industries, Ltd. (MHI) at the NRC headquarters building in Rockville, Maryland for the United States - Advanced Pressurized Water Reactor (US-APWR). The meeting notice was issued on February 11, 2014, and was available through both the NRC public meeting website and the Agencywide Documents Access and Management System (ADAMS) under accession number ML14041A131. The list of meeting attendees is included as an enclosure.

On November 5, 2013, MHI issued a letter stating its intention to reduce its support and to slowdown the review of the US-APWR Design Certification Document (DCD) application. This letter can be found in ADAMS under accession number ML13311A109. The purpose of this DCWG meeting was to discuss the status of the US-APWR DCD review for each chapter.

The meeting commenced with opening remarks, an introduction of attendees, announcement of meeting logistics and then the background and meeting purpose were discussed. These logistical items, an MHI informational briefing (ADAMS accession number ML14079A396) was presented and discussed. The briefing covered the background of the slowdown, the status of chapters and future activities. Following this presentation, MHI discussed the format of its US-APWR Chapter Summary Reports concurrent with the Chapter 1 discussion. MHI's final US-APWR Chapter Summary Reports were submitted to the NRC by a letter dated March 31, 2014, and are available in ADAMS under accession number ML14092A434. Chapter statuses were then discussed in sequential order for the remainder of the meeting. For each chapter, current open issues such as requests for additional information, open items, etc., were presented by the MHI chapter manager as the NRC chapter manager checked for consistency with the NRC status. A few small status oriented discrepancies were discussed and correct resolutions were documented. The public in attendance had the opportunity to ask questions of
