SUBJECT: IMPROVEMENTS IN DECOMMISSIONING STATEMENT OF INTENT FOR
NUCLEAR FUEL SERVICES

Dear Ms. Bayless:

We have reviewed your letter dated September 4, 2013, and we have informed Nuclear Fuel Services that we will accept it as a decommissioning funding instrument for Materials License Number SNM-124. Our review found that the letter met the requirement in Title 10 of the *Code of Federal Regulations* Section 70.25(f)(4), that it contains a cost estimate and a statement indicating that funds for decommissioning will be obtained when necessary. However, our guidance suggests that the letter should be signed by a higher level official. Specifically, NUREG-1757, Volume 3, Appendix A, Section A.11, states that the signatory of a statement of intent should have the authority to request and obtain decommissioning funds from the appropriate funding body when necessary. For your agency, we believe this would be a senior official such as the Chief Financial Officer. Our guidance is available at <http://www.nrc.gov/reading-rm/doc-collections/nuregs/staff/sr1757/>.

The purpose of this letter is to request an improved statement of intent signed by such an official. The model language for the statement is as follows:

As [*insert title*] of the U.S. Department of Energy (DOE), I exercise express authority and responsibility to request funds from the U.S. Congress for decommissioning activities associated with operations authorized by U.S. Nuclear Regulatory Commission Materials License No. SNM-124. This authority is established by [*insert reference to documents governing control of funds*]. Within this authority, I intend to request that funds be made available, when necessary, to decommission the Nuclear Fuel Services facility in Erwin, TN. I understand that the cost estimate for decommissioning activities under the DOE/TVA Interagency Agreement DE-SA09-01SR18976 is \$8,076,000.
