On February 26, 2014, staff from the U.S. Nuclear Regulatory Commission (NRC) met in a closed meeting with representatives from Westinghouse Electric Company, LLC (WEC) at the U.S. Nuclear Regulatory Commission office, 11601 Landsdown Street, Rockville, Maryland 20852. The purpose of this closed meeting was to discuss a safety analysis overview associated with the Westinghouse small modular reactor (W-SMR) design. Topics discussed included long term cooling, containment response, and transient analysis.
