SUBJECT: SUMMARY OF JANUARY 7, 2014, PUBLIC MEETING ON THE
USE OF HIGH DENSITY POLYETHYLENE PIPING AS
REPLACEMENT MATERIAL FOR UNDERGROUND PIPING

On January 7, 2014, a public meeting was held between the U.S. Nuclear Regulatory Commission (NRC) staff, representatives from the Nuclear Energy Institute (NEI), and other nuclear power industry stakeholders. The purpose of this meeting was to discuss relief requests for past and future use of high density polyethylene (HDPE) piping as a replacement material for buried metallic piping. The discussion centered on industry experience with HDPE piping in both foreign and domestic nuclear power plants.
