
I, Eugene Eckholt, being duly sworn, state:



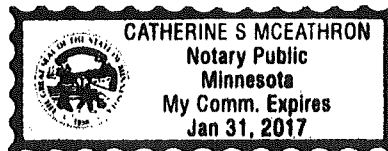
