CHAIRMAN MACFARLANE: Alright, we have an affirmation session?

ANNETTE VIETTI-COOK: We have one item for affirmation. It is on Aerotest Operations, (Aerotest Radiography and Research Reactor). The commission is being asked to act on a memorandum and order responding to: (1) the hearing request of Aerotest Operations Inc. and Nuclear Labyrinth, LLC (together referred to as the companies), on three related NRC Staff actions denials of the license transfer and license renewal applications and issuance of a related enforcement order, and (2) the NRC staff's "motion to sever" the license transfer proceeding from the license renewal proceeding.

The commission has voted to approve a memorandum and order which: denies both the NRC staff's motion to sever and the companies' request to consolidate the three matters, grants the companies' hearing request on the denial of the license transfer application, defers consideration of the companies' hearing request on the denial of the license application, and the associated enforcement order, and provides further direction for the license transfer proceeding.
