Dear Mr. Grohnert:

Enclosed is Amendment No. 07 to your NRC Materials License No. 13-32721-01 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

In your application dated February 7, 2014, you indicated that a new storage area has been constructed and you provided sufficient information for us to approve use of that area with this amendment. In addition, you requested that the temporary storage area established to facilitate renovations, and previously approved by us, be decommissioned. You provided a facility decommissioning report to support your request. The NRC staff has reviewed all of this information, including the final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from the temporary storage area at your facility at 2355 Endress Place, Greenwood, Indiana, and residual radioactive material attributable to licensed activities does not exceed current NRC criteria. Therefore, you may release this area for unrestricted use.

Please review the enclosed documents carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. 
strongly encourage you to review this material and adapt it to your particular needs in order to develop and maintain a positive safety culture as you engage in NRC-regulated activities.
